

Dear Madam, Dear Sir,

To continue communicating / collaborating, we recommend that you resend the e-mail with the statement "ACCEPT" or let us know at rpd@certex.ro an e-mail with the subject "ACCEPT".

We inform you that as of May 25, 2018, Regulation 2016/679/EU on the protection of natural persons with regard to the processing of personal data and on the free movement of such data (hereinafter referred to as the "RGPD") will be implemented by all EU countries. The RGPD seeks to create a uniform legislative framework across the European Union.

Your personal data is in the database of the **NATIONAL R&D INSTITUTE FOR TEXTILES AND LEATHER - INCDTP** Bucharest, because it was obtained directly or as a result of previous collaborations and / or correspondence, or as a partner, customer or supplier of our institute, or has been selected from a database to which you have subscribed, or has been made public by you through publications in an ad or in a meeting / conferences you attended with us.

In this context, INCDTP BUCHAREST is in line with the provisions of Regulation 679/2016, and implements the necessary security and confidentiality measures so that the personal data you have at our disposal can be processed safely.

We process your personal data (such as name, surname, business e-mail address, business phone) as a legal obligation (in situations / centralizers or reports that we are required to elaborate on current business); for contractual purposes, and depending on the type of collaboration, in the legitimate interest, ie to keep you up to date with our activity, services and / or events that we organize.

Since your personal data will be used only in connection with the purpose for which it is provided, we will inform you that we are implementing the legal provisions in force regarding the undertaking of the security measures imposed in this situation.

According to Regulation no. 679/2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46 / EC (General Data Protection Directive - RGPD), you have the right of access data rectification, right to be protected, the right to restrict the processing, the right to opposition and to the automated individual decision-making process, the right to portability of data and the right of the complaint formula.

You may oppose the processing of your personal data and request the deletion of the data without affecting the lawfulness of processing performed on the basis of your consent, but only after the legal deadlines for archiving the documents drawn up and related documents have expired.

In order to exercise the rights set out above, you will be able to submit a *written, dated and signed application* to the operator. In the request, you can show whether you want the

information to be communicated to you at a specific address, or through a mailing service to ensure that the handover is done only personally.

If you wish to receive the reply by e-mail, you can submit the written, dated and signed request, in scanned form, by mail to rpd@certex.ro, by e-mailing us the email address you wish to communicate in view of that you are informed that the way in which e-mail is communicated is not complete, so you take the risks of communicating electronically.

The operator is required to notify you of the measures taken or the legal limits on the possibility of applying for your application, in compliance with any communication option you have made. If any of your data is incorrect or changes, please let us know as soon as possible.

We state that we will store the personal data for the period necessary to achieve the specific goals pursued and specified above, as well as the legal terms for their preservation, provided that appropriate safeguards are in place to protect them in accordance with the legal provisions.

After the legal retention period of the data / documents containing your data has passed, the legal provisions on archiving corresponding to each type of data / document will apply, and after your personal data will be erased / destroyed.

We also inform you, if we have not received your consent to the use of personal data (name, surname, e-mail address, etc.), your personal data will be deleted.
